Wyoming Colorado Intertie, LLC (“WCI”) filed its *Application for Authority to Sell Transmission Rights at Negotiated Rates* in this docket on March 11, 2009. The application is currently pending before the Commission.

The purpose of this letter is to inform the Federal Energy Regulatory Commission that AES Corporation, Inc. has transferred all of the membership interests in AES Trans-Elect Holdings, LLC (“AES Trans-Elect Holdings”) to LS Power Transmission, LLC, a subsidiary of LS Power Associates, LP whose general partner is LS Power Development, LLC (“LS Power Development”). AES Trans-Elect Holdings owns AES Trans-Elect, LLC, which in turn owns WCI, the applicant in this proceeding. WCI is now a subsidiary of LS Power Development. The transfer occurred on April 17, 2009. WCI does not own or operate any Commission-jurisdictional assets.

This transfer has no material effect on WCI’s application in this proceeding. WCI is unaffected by the transfer. WCI is still owned by AES Trans-Elect Holdings, as stated on page 3 of the application. The only difference is that WCI’s upstream owner, AES Trans-Elect Holdings, is no longer a subsidiary of AES Corporation, Inc. and is now a subsidiary of LS
